The Principal's Message...

COVID-19 Update / Reminders

A big thank you to our parents, carers and families for continuing to support and adhere to the department's COVID guidelines. As always, it is very much appreciated.

A special well done to our new Kindergarten students who have all settled in extremely well and have been quite amazing in the way they have already developed independence and resilience. Well done mums and dads on preparing them so well for 'big school!'

A few reminders:

- Where possible, please contact the school by phone or email, rather than come into the office. Many organisational aspects can be done this way, from ordering uniforms to requesting notes.
- If you do come into the office, you must sign in via both the Service NSW and school's QR codes. If you do not have the technology to do this, you will need to fill in a visitor form and declaration every time. These measures are required for contact tracing purposes.
- At this stage the vast majority of students are familiar with their morning and afternoon pick up. Thank you for ensuring your children are aware of what is in place.
- Continue to be mindful and follow social distancing expectations, particularly for those picking up children from the bottom hard court area. Unfortunately, we cannot avoid the congestion around the gate area and ask parents and carers to be <u>patient and courteous</u> with each other. It is OK to wait a minute or so before coming in or leaving. This may lessen the congestion. Teachers will not let students leave without you. It might also be wise if you can organise an alternate meeting spot for your children, for example, meeting your child outside the front gate where it is less crowded.
- If your child is unwell and particularly if they have even mild flu like symptoms, it is a department of
 education requirement for them to have a COVID test. <u>When a negative result is given to you, you must
 present this to the office before your child is allowed to return</u>. If they present unwell at school, you will be
 called and asked to come and pick them up. It is vital we all comply with this to assist us all to remain safe
 and well. This also applies to school staff.
- Enhanced cleaning measures remain in place. Students are also encouraged and reminded often to wash their hands and use hand sanitiser.

Lunches

Please ensure your child brings enough food for recess and lunch each day, and also a small piece of fruit or vegies for crunch n' sip time. If they don't bring lunch and we are aware of this in time, the office staff will contact you and you'll be asked to bring them something. The canteen can provide lunch on Wednesdays and Fridays when they're open, and then invoice you for the cost of this lunch. On other days, students will be provided with something snacky, such as dippits.

Voluntary Contributions

As a NSW public school we do not set compulsory school fees. Instead we may request a voluntary contribution. As implied, it is a VOLUNTARY contribution and students are not disadvantaged if families do not make this contribution. On the last page of this newsletter is the voluntary contribution page which has further information about this scheme.

Attendance

I cannot stress enough how important regular and punctual attendance at school is. Please ensure your children come to school, and on time, every day. There is a correlation between irregular attendance and academic progress and social development and the impact can have lasting effects on students. Of course, if children are not well, they should stay home until they are well enough to return to school. Please do not send children to school knowing they are unwell as this may cause other students and staff to also become unwell. If children have any flu like symptoms, they must have a COVID test and cannot return to school until a negative result is presented. This also applies to staff.

School Photos

School photos (class, groups & individual) will be taken on Wednesday 24th February with sibling photos on the following Monday 1st March. Information about school photos and a photo ordering envelope have already been sent home. Online orders can be made by going to <u>www.advancedlife.com.au</u> and entering the code **BND CZE HMQ.** There are a number of options available. Ordering online is the preferred method.

Gymnastics

It was great to see all our students participate in the gymnastics program on Friday last week and Monday this week. We provide the first session at no cost so all our students can see just how good the program is. We have a company come to the school to provide this opportunity. We do this because we don't have the specialised equipment nor the staff qualified to run the same type of program. The school subsidises the cost of this by around 70% and we only ask for \$10 for the whole program per student (not \$10 per week). We do this in order to have as many students as possible participate. We would love to see 100% participation, so if you are yet to return the note and payment, please do so soon so they don't miss out.

Swimming Carnival

Good luck to the students participating in next week's twilight swimming carnival. Parents and carers, please note this carnival is after school and only open to students who turn 8 years old and above this year. It is also a requirement they can <u>correctly and competently</u> swim particular swimming strokes without assistance for 50 metres, and 100 metres for the 100 metre race.

Save the Date

During week 5 we will be hosting Meet the Teacher Information Sessions for Parents. Due to ongoing COVID restrictions, most of these meetings will be held virtually via Zoom. Notes and details on how to register a Zoom account will be sent home at the start of next week.

Awards

Through our Positive Behaviour for Learning (PBL) program we have many ways to recognise and celebrate students with great behaviour. Individual classes will usually have a system for their classroom and as a school we have our whole school trade-up system. This year we are also introducing a *Bronze, Silver and Gold* level system which will acknowledge those students who consistently demonstrate they are safe, respectful learners on a daily basis. If there is anything you are not sure of, please speak with your child's class teacher.


P & C Meeting

Whole School Positive Reward Systems



This system is based around students meeting set criteria for each level and works on a yearly basis. At the start of each year, all students work towards earning their BRONZE award in Term 1.

- If they receive their Bronze award in Term 1, they then work toward achieving their Silver award in Term 2 and then Gold in Term 3.
- If they don't meet the criteria to achieve an award, they work toward it in the following term.
 - toward it in the following term. The students achieving each level are recognised at an assembly at the end of each term. Because of the number of students who may receive an award, the certificates are presented by their teacher in class.
- Year 5 students who wish to be nominated for a School Captain or Prefect role must be at gold level or working towards gold level in Term 4.

Students in 3-6 are encouraged to read 20 books by themselves and log



Compulsory School Attendance

Information for parents

Education for your child is important and regular attendance at school is essential for your child to achieve their educational best and increase their career and life options, NSW public schools work in partnership with parents to encourage and support regular attendance of children and young people. When your child attends school every day, learning becomes easier and your child will build and maintain friendships with other children.

What are my legal responsibilities?

Education in New South Wales is compulsory for all children between the ages of six years and below the minimum school leaving age. The Education Act 1990 requires that parents ensure their children of compulsory school age are enrolled at, and regularly attend school, or, are registered with the Board of Studies, Teaching and Educational Standards for homeschooling.

Once enrolled, children are required to attend school each day it is open for students.

The importance of arriving on time

Arriving at school and class on time:

- Ensures that students do not miss out on important learning activities scheduled early in the day
- Helps students learn the importance of punctuality and routine
- Give students time to greet their friends before class
- Reduces classroom disruption

Lateness is recorded as a partial absence and must be explained by parents.

What if my child has to be away from school?

On occasion, your child may need to be absent from school, Justified reasons for student absences may include:

- being sick, or having an infectious disease
- having an unavoidable medical appointment
- being required to attend a recognised religious holiday exceptional or urgent family
- circumstance (e.g. attending a funeral)

Following an absence from school you must ensure that within 7 days you provide your child's school with a verbal or written explanation for the absence. However, if the school has not received an explanation from you within 2 days, the school may contact you to discuss the absence.

Principals may decline to accept an explanation that you have provided if they do not believe the absence is in the best interest of your child. In these circumstances your child's absence would be recorded as unjustified. When this happens the principal will discuss their decision with you and the reasons why.

Principals may request medical certificates or other documentation when frequent or long term absences are explained as being due to illness. Principals may also seek parental permission to speak with medical specialists to obtain information to collaboratively develop a health care plan to support your child. If the request is denied, the principal can record the absences as unjustified.

Travel

Families are encouraged to travel during school holidays. If travel during school term is necessary, discuss this with your child's school principal. An Application for Extended Leave may need to be completed. Absences relating to travel will be marked as leave on the roll and therefore contribute to your child's total absences for the year.

In some circumstances students may be eligible to enrol in distance education for travel periods over 50 school days. This should be discussed with your child's school principal





My child won't go to school, What should I do?

You should contact the principal as soon as possible to discuss the issue and ask for help. Strategies to help improve attendance may include a referral to the school's learning and support team or linking your child with appropriate support networks. The principal may seek further support from the Home School Liaison Program to develop an Attendance Improvement Plan.

What might happen if my child continues to have unacceptable absences?

It is important to understand that the Department of Education and Communities may be required to take further action where children of compulsory school age have recurring numbers of unexplained or unjustified absences from school.

Some of the following actions may be undertaken:

 Compulsory Schooling Conferences

You may be asked, along with your child, to attend a Compulsory conference will help to identify the supports your child may need to have regularly. The school, parents and agencies will work together to develop an agreed plan (known as Undertakings) to support your child's attendance at school.

Application to the Children's Court . - Compulsory Schooling Order

If your child's attendance at school remains unsatisfactory the Department

may apply to the Children's Court for a Compulsory Schooling Order. The Children's Court magistrate may order a Compulsory Schooling Conference to be convened.

Prosecution in the Local Court

School and Department staff remain committed to working in partnership with you to address the issues which are preventing your child's full participation at school. In circumstances where a breach of compulsory schooling orders occurs further action may be taken against a parent in the Local Court. The result of court action can be the imposition of a community service order or a fine.

What age can my child leave school?

All New South Wales students must complete Year 10 or its equivalent. After Year 10, and up until they reach 17 years of age, there are a range of flexible options for students to complete their schooling.

Working in Partnership

The Department of Education and Communities recognises that working collaboratively with students and their families is the best way to support the regular attendance of students at school

We look forward to working in partnership with you to support your child to fulfil their life opportunities.

LEARNING & ENGAGEMENT

If a student misses as little as 8 days in a school term, by the end of primary school they'll have missed over a year of school.
